

ODE ITC Call – 1/3/2023

FY23 Student Collections (S and SOES) – Initial Student Collections are now closed. The Midyear Student Collection (S) for traditional districts and Final Student Collection (SOES) for community schools are now open. Districts are encouraged to submit data. ODE will continue to use data from the initial collection until new data is submitted.

FY23 Initial Staff/Course Collection (L) – closes January 31, 2023. Certification and licensure is based on this collection. There are still about 30 entities that have yet to submit this data. An updated list of these districts will be sent later this week.

FY23 Initial Exiting Student Follow up – The initial window closes this Friday, January 6, 2023. There are still 50 entities that have one or more CTE students in their follow up who have not yet submitted. Districts should also review the Gen Issues list for the follow up collection. This will show individual students who have not had any information reported. The appeal window opens next week (it's a short appeal - less than a week). Then there will be a short window for districts with approved appeals to submit data. Districts do not need to appeal all of their students. If additional information was received on a CTE student that should be included in the data that will be submitted to the feds, this is an appropriate reason for an appeal. If a district has no CTE students and did not submit at all during the initial window, or has no CTE students that would require an appeal, they can submit data when the window opens in February. There is plenty of time to submit Graduate and Students With Disability follow up data for accountability and report card usage. ODE has been pretty well caught up on help desk tickets related to CTE follow up, though there are some that have been put on hold regarding Grad and SWD. They should be able to get caught up on these soon - had to focus on the CTE issues as this initial window is coming to a close.

ODE is in the process of writing the code, and have received the first version of the file from the National Student Clearinghouse to see if they can add college enrollment data to the CTE data. This may not be completed in time to be included in the federal submission on January 31, 2023. But as reports are written to provide district feedback for the FY23 Final Exiting Student Follow up collection, they should be able to include this data.

Q&A

Q: Should a district go ahead and submit, even if they have no CTE students, in order to get students removed from the list who should not be on the list? With the updated manifest version, does this matter?

A: If districts have already submitted under a prior version of the manifest with the incorrect IRNs, they can still use the prior data set but collect/prepare would resolve the IRN issues. In the end, if no students are CTE, there's really nothing they can mess up - there's plenty of time to submit the Grad/SWD follow up data in the final window. However, still encourage districts to submit. If there is no data at all (no prior submission and no file in the DC), then there is no problem if there are no CTE students for that district.

Q: For grad follow-up, are out of state resident tuition students that an entity graduated supposed to be in the file?

A: In general, any student for whom a district issued a diploma should be in the file. However, please submit a help desk ticket.

Q: EOC History for FY23 grad requirements - district has a student that did not test in grade 10 (FY21) in American History. The district emailed the grad requirement office and was told students did not have to test that year. But the "W" doesn't work because they were in 10th grade - only valid for 11th and 12th grade students that year. Is this something that is a software issue, should it be a ticket to ODE?

A: In the end, ODE EMIS doesn't say a student is a non-grad if something appears to be missing. If the district has the email to confirm the test is not needed, the district has the documentation needed. The student would not be able to earn the seal based on this, but report what is - if the student meets grad requirements based on local analysis, the district reports them as a graduate.
