

ODEW EMIS-ITC Call – 01/22/2024

**FY24 Initial Staff and Course Collection** - The first window closes next week on Wednesday, January 31st. ODEW is sharing lists with ITCs of districts who have not submitted at all during this collection. It's important for districts to make sure all courses are in and they are submitting data. The Teacher Licensure Status Report should be reviewed to ensure everything is reported accurately, so it will be correct on the local report card. The licensure information from the first window is the data used for the LRC.

**FY24 Initial Exiting Student Follow Up** - Districts can no longer file appeals for CTE Follow Up Data (which is used for Career Tech federal reporting and accountability), but those with approved appeals have until Tuesday, January 23rd to get updated data submitted. If possible, please submit by 5:00pm on Tuesday, though data will be accepted through 11:59pm on January 23, 2024.

**FY24 Kindergarten Readiness Assessment** - Still kind of floating on the KRA collection. The vendor is continuing their QA process for the files to ensure everything is correct. They are hoping to have updated files this week. Once this is confirmed and files are available, ODEW will update the close date for this collection. We do know the close date has been extended, but don't have a specific date just yet.

**EMIS General Training (Jan. 29-Feb. 2)** - The upcoming round of EMIS General Training will begin next week. No registration is needed; training information and documentation can be found on the website: <https://education.ohio.gov/Topics/Data/EMIS/EMIS-Resources/EMIS-Training>

**Funding change for Drop Out Prevention & Recovery Schools** - Changes in the budget bill allowed DORP schools to be funded a little differently if they have industry credential courses. That change in funding is expected to go to production this week. These DORP schools who do offer industry credentials will want to review their Career Tech Reports and FTE Reports - there are new adjustments that will come into play. Some schools will not see a change in funding because they are already reporting full time industry credential courses, but those who have students that are *less than full time* may see an increase in funding.

**FY24 EMIS Change - 24-101** - Are there any follow up questions regarding the discussion from the January 10th ODEW EMIS Change call surrounding the upcoming OTC change (24-101)? We want to ensure the documentation covers any potential questions.

**Q:** With the known changes and expected changes, is there a choice ODEW is expecting to be reported in the interim until software vendors are able to get updates applied?

**A:** Go ahead and put the courses and staff in, etc. If students are in those courses but not over full time, go ahead and update their base percent of time. Keep a list of courses where the delivery method needs to be updated, and which students who would be over 100% and need the sent reason / sent to percent of time corrected. As courses are submitted, certification checks are not run during L2 so the course will not fail that certification check. Depending on certain variables in the course, it is possible schools will start to be funded right away. In other cases, the funding will not occur until after the additional codes are added.

### **Q & A**

**Q:** District received a letter regarding a new element for PBIS reporting - this is specific to coaches and how they are being trained. The letter indicates EMIS is supposed to report this information.

**A:** Not clear on why the letter is worded the way it is, but according to the business office there is no EMIS reporting requirement for this. This answer is also available on previous tickets in the helpdesk, if needed in writing.

**Q:** Do districts still have until midnight for ODE to receive their Initial L data on Wednesday, January 31st?

**A:** Districts have to hit submit in the Data Collector by 11:59pm on January 31st. If they wait until midnight, submit will not work.
