

ODEW EMIS-ITC Call – 6/24/2024

Secure Data Center (SCR) – There was an issue with the report collector at SSDT a week ago. Due to many districts submitting their Student Cross Reference (SCR) once a week, ODEW decided to wait and see what issues were cleared up. However, there are a lot of districts still remaining with submissions that were not properly processed. SSDT will be reaching out to ITCs that have districts where their SCR submission was not properly processed so those districts can get their SCR re-submitted before that window closes. The SCR collection closes on July 12th.

ODDEX - Early Warning System (EWS)– A quiet release of the module was done on June 13th. EMIS Coordinators can go in and check their data. If anyone has any questions, please have your ITC submit those to David Ehle directly via email and cc EMIS@education.ohio.gov. For enhancement requests, please submit an EMIS Enhancement Request at <https://education.ohio.gov/Topics/Data/EMIS/Reporting-Responsibilities/EMIS-Enhancement-Requests> (please choose the category of “System” if EWS is not available). ODEW plans to make small enhancements to the EWS; for example, adding more download files.

ODEW will be doing a public release in mid-September for both Progress Towards Grad (PTG) and the EWS. The EWS looks pretty similar now to how it will look in mid-September. ODEW will be going to several different conferences to go over this new module.

Now that the EWS has been published, ODEW will be shifting some of its attention back to the PTG module. They will be “flushing out” the reports on PTG so that’s ready to go for mid-September. ODEW is also in the design phase of the Student Support Supports Intervention Inventory. This is an add-on to the EWS that will allow districts to create student plans for intervention for students who are having challenges with attendance, course work, and/or behavior to help them try and get back on track towards graduation.

Submission Notifications/Emails – Emails have been going out to ITCs with information on who has not submitted certain collections and information on who has not submitted for an extended period of time. Please encourage your districts to get those collections submitted.

Derive Reading Diagnostic Result Report (LTRC-001) – An EMIS Newsflash was sent out on June 20th about the reading diagnostic report. Districts are encouraged to look at this and work through any issues they may have locally.

Students that were previously appearing as not on track (NO) are now showing as required not assessed (RN). These students are being reported with the incorrect assessment subject code for their reading diagnosis per the FAQ, which can be found here

The biggest issue is with the i-Ready. Districts were reporting one or more of the available Assessment Area Codes for i-Ready but not the CAIR Assessment Area Code. As stated in the FAQ for i-Ready, CAIR should be reported for districts using the i-Ready assessment for the diagnostic. If districts have already reported their diagnostic scores with CADF, CADI, CAML, or CAPR, they can leave these scores in and

ODEW will ignore those scores. However, districts need to make sure they have their diagnostic scores reported with CAIR, or else students will show as required, not assessed.

ODEW has been working on a fix for the 1600 students whose assessment date was outside their enrollment date. There is a good chance that this fix will be published by the end of the week. The issue with the KRA will also likely be fixed by the end of the week.

ODEW has heard from one assessment vendor that their understanding of the assessment results may not work. If ODEW figures out they need to do something else for those districts using this particular assessment vendor, ODEW will get this fix completed as soon as possible. They will also get information added to the FAQ and sent out to districts in an EMIS Newsflash if a fix is needed.
