Items from David Ehle

- 1) FY17 processing
 - a) Newsflash announcement that FTE reporting for Traditional districts is now open. Reporting already open for Community Schools, though it opened late.
 - Two districts submitted in first 15 minutes and were included in Friday's processing
 - ii) Encourage districts to submit. They will get FTE reports back the next day.
 - iii) Checks and adjustments in place so as more districts submit, the number of adjustments will go up and districts will be able to find issues with reporting students who have moved.
 - b) School Options Reporting Enrollment (SOES) submission is available
 - i) 560 districts have submitted
 - ii) Funding for September will be based on Sept. 22 data. Any data submitted before 5:00 PM will be included as the basis for October payment.
 - iii) Several have submitted student data but not contact data
 - (1) Will show as all missing contact data until that is submitted
 - iv) Will use Default calendar until district/school calendar data is submitted
 - v) Community schools have 9 more days to get submit their FTE data. Remind them to get their data submitted.
 - vi) Will fund on the 30 days of submission in SCR
 - vii) Not starting from day 1 to do funding adjustments if you take more than 30 days to get a student reported
 - viii)The 30-day requirement will be implemented later this year
 - ix) All entities should be reporting in Cross Reference
 - c) Calendar Collection
 - i) Initial collection open
 - ii) Will close Sept 30 and will re-open in October.
 - iii) Need initial calendar from all entities, especially community schools reported by the end of September
 - d) Issue with student who withdrew on last day of last school year
 - i) Fixed that issue so they won't show as missing students
- 2) FY16 Yearend Supplemental Reporting
 - a) Open now for capital assets, federal schedules and civil proceedings
 - b) Finance appeal opening Sept. 19 for report card data
 - i) 7 entities didn't report at all or had significant issues

- ii) Some that had Maintenance of Effort issues, Office of Exceptional Children and Office for Programs will reach out to these district
- iii) Finance Appeals window closes 29th or 30th
- iv) October 3-7 is submission of appeals data for finance
- v) Will reopen the collection request just for those entities that have approved appeals
- vi) Updated data will be rolled into the Secure Data Center (SDC)
- vii) Expect an October Report Card release containing appealed data at the end of October
- c) report card toward end of October
- 3) Report card
 - a) Will be released this Thursday
 - b) Everything except Value Added data is final
 - c) Secure Data Center (SDC) closes early tomorrow morning and won't be open until the end of the week
 - d) Impact of the value added data will go out through the forms application rather than the Secure Data Center
 - i) Data will be available hopefully tomorrow
 - ii) Depends on when ODE gets the file
 - iii) Message should go to Superintendents when data is available
 - e) If anyone finds an issue with the report card
 - i) Contact Office of Data Quality regardless what the issue is
 - ii) Will do watermark or whatever needs done
 - Newsflash was sent to Superintendents on Friday so they should have information about the data being in the forms area
- 4) FY16 Open Windows
 - a) FY16 Graduate Reporting window, working on reports, will be coming out quickly
 - i) Reports hoping to get out end of this week or first of next week
 - ii) Will not include students as graduate who are using new alternative testing options
 - (1) A student under OGT can use ACT, SAT, AP, EOC exam to meet requirement
 - iii) Will show up on Grad Test Requirement
 - (1) Only show OGT
 - (2) Need OGT or one of the alternate assessments
 - iv) Will send out a note when the report comes out if those updated assessments will be not included, then send out a note when they are included
 - v) Grad Test Required and Grad Info will come first
 - vi) Longitudinal Grad Rate reports will come later

- vii) If student is enrolled in FY17, that will take them out of the grad rate and their diploma will not count
 - (1) Make sure data for graduating students is correct especially JVSD Students
- viii)FY16 Period G Window closes October 21, not expected to extend the window because of Federal reporting in November. Trying to be on-time for Federal reporting this year.
- ix) Appeal window but no date yet
- b) Spring Early Learning Assessment data
 - i) Collection Window will be opening any day
 - ii) Close in October, still trying to finalize the date
- c) CTE Assessment
 - i) Still Open, Closes October 14
- d) OELPA Collection yet to open
 - i) No firm date when results will be available
- e) Working on Final Number 2 payment
 - i) Hope to have done next week
 - ii) Flagging in Student Options Enrollment System (SOES) closes Thursday, September 15
 - iii) Plan to have report for FY16 Final #2 FTE reports, CTE Reports, Funding reports on ODE's website next week
 - (1) CTE and FTE reports are on the expired collections
 - iv) Funding appeal window open October 3-21
 - v) Final #3 payment in December
- 5) FY15 Funding
 - a) For vast majority of districts, FY15 funding is done
 - b) Few districts have appeals that haven't been resolved
 - i) 10 or less will have updates to their funding still
 - ii) May need assistance from ITC
 - iii) Work underway to get everything wrapped up
 - c) Very small set of districts impacted with FY15 funding cleanup
- 6) CCP
 - a) Big focus this week now that report card is up to date
 - b) Hope to have everything loaded and updated prior to OEDSA
 - c) Loading college updated data today
 - d) Colleges are to report home district and JVSD will be assigned based on courses reported by K-12 entity
 - e) Agreement updates will be loaded
 - f) Public districts do not report home schooled students/courses
 - i) Home district is not issuing the diploma

- 7) No change call this week
 - a) Go over changes at OEDSA
 - b) Send topics to David if there are specific areas that should be addressed
 - i) Will be addressing new data collector changes

- 9) Withdrawal date for summer graduates' clarifications
 - a) Must have a date prior to first day or school
- b) Alternate assessments will eventually be included, but not first round of reports 10)Data Collector Update
 - a) Data collector progress tab is showing all collections regardless of the 'Don't show expired collections' flag set
 - i) Send screen shot of filters to Teresa Williams
- 11)CCP and JVSD Reporting clarifications
 - a) Who reports enrollment reports the course for College Credit Plus (CCP)
 - b) If student is 100% JVSD, then JVSD should be reporting all College Credit Plus (CCP) courses
 - If student is satellite student, resident district reports if it is not part of the JVSD course
 - d) If College Credit Plus is replacing district credit, district reports
 - e) If College Credit Plus is replacing JVSD credit, JVSD reports
 - f) Whoever reports the course data is where the billing goes
 - g) If both report the course or neither reports, course will be proportionally split between the two entities
 - h) Would be a finance data appeal if the wrong entity was charged for the College Credit Plus course
 - Both could have agreements because agreements are at delivery method level, not course level
 - j) Full time at JVSD and no one reporting College Credit Plus courses, full funding would be from JVSD
 - k) All funding is as of census date of the course
- 12) For Students who are Home Schooled and College Credit Plus (CCP)
 - a) Do not enroll in the home district
 - b) Cannot be home schooled and attend resident district at same time
