

ODE EMIS Conference Call Summary

9.19.19 Notes provided Naja Bailey (META) and Catherine Wright (NEONET)

FY20 Funding - Relatively close for the first funding pull for FY20 for community schools. All the community school funding is based on present year data. The add in for the district is still based on last year's dollar amount but the actual deduct and the amount of money that goes to community schools is based on current year data. ODE plans on pulling that data first thing on September 23rd which means that community schools have until 5pm on Sunday, September 22nd to submit their data and resolve flags, etc. About 60 community schools still need to report FY20 data. ODE has loaded last year's final FY19 FTE into the FTE Daily Summary process. As a reminder, the last row of the FTE Daily Summary report is usually the 30-day average. However, since this it's too early in the FY20 reporting process to have 30 days to average, we've currently named that column "Prior Year" and are populating it with the final FY19 FTE data from last school year for that community school. That report can be used to see how their FTE is comparing current year to last year once the data is processed. Also, it's important to look at the FTE Detail Report for kid-by-kid issues that may need to be resolved.

Data Collector Messaging – There will be a message sent out through the Data Collector specifically for Community schools that will also refer to the funding deadline.

FY20 Funding/Processing – For the most part ODE is processing all relevant areas for FY20 data. Still finishing up the address check for FTE funding. It is not currently zeroing out all the FTE that it should when the student is missing their address within SOES for FY20. There is a query in SOES in ODDEX for community schools to pull the lists all students that are missing their addresses. Also, getting ready to run Federal Child Count (FCC) data so that should be out there very soon and have not yet run tuition data in ODDEX for FY20 but that will be coming very shortly.

Q: Will you be talking at OEDSA about funding for TRAD districts and the impact of the budget bill?

A: That is not something that is on the current list to talk about because we have a challenge for traditional school districts this school year. While much of their funding is based on last year's data, there are still parts that is based on current year data. There is a strong possibility that while this year's funding may not be based on this year's data, some future years funding may be based on this year's data.

Q: Any way you could talk about the funding parts?

A: We are hesitant there because we don't want everyone to just focus on those specific parts. Because in addition to all the parts that do not impact funding this year, they could very well impact funding in future years. This data does still go into accountability and FTE is woven into several different accountability processes as well for all students.

New Data Collector – Any comments/questions on the new features please email David.

Q: In the Received Files – If you click on the "Help" button for the CTE Enrolled by SSID for Career Tech it doesn't take you to the description it directs you to the release notes page for ODE but then you have to search for which release notes had that report.

A: That is not what it should be doing so we will check on it and get that fixed.

Q: Are you going to use notifications for things like Preschool ECE students and will be able to use that email for things like that where checks are not into place yet?

A: There are a couple of instances when we will use that individual LEA email piece. In general, we can get a Gen Issues added within a couple days. We will continue to do Gen Issues when we have higher volume issues or when we can clearly define what it is that need to be sent out. Where we use that email piece is when a data manager is pulling data because of a data request or looking at data for a research purpose. Also, when we notice something about a particular districts data that doesn't normally appear on any report but we want to draw their attention to.

One other reason is if we need to get information out to districts and do not have a few days to create the Gen Issues, then we would use the email piece. Also, when we are approaching the end of a collection period we would email districts that haven't submitted their data yet.

Q: The processing time where you go to tables finish, there are still some processes like Gen Issues and some of the Level 2's that didn't finish until about 10:00am this morning. Is there something that can be one to speed that process up?

A: Just pay attention to the update dates and updated information because the lag is probably due to just processing more and more data at ODE. And while it is the case that we try to finish as much as we can overnight, there will always be changes to Gen Issues during the day because Gen Issues run during the day.

Q: Is that the same process with the Grad Issues?

A: On the Grad Issues there is a problem with the date appearing that is being worked on.

Q: Has the District Sign off document been updated to show who has not completed it yet? Can they still sign off now since the deadline has passed?

A: I would have you submit an email to Office of Data Quality since they handle those processes.
